PARISH LENGTHSMAN

RECREATION GROUND

Trees

Nothing further had been heard regarding the trees since the previous meeting so it was agreed that Dave Hewitt be contacted again.

Renewal of lease

It was agreed that the Parish Council needed to pursue the landlord for completion of the appropriate paperwork regarding the renewal of the lease.

Grass cutting

It was noted that the grass had been cut once already by Tom Bell this season. Efforts were still being made to source a suitable piece of equipment for cutting which the Parish Council could purchase itself.

Pavilion

It had been previously agreed that the pavilion should be repaired and tidied up. The Clerk advised that a new fund offered by Ribble Valley BC was intended for smaller capital projects and the improvement of the pavilion may therefore qualify for such a grant.

TREE PROTECTION ORDERS – field off Skipton Road

It was agreed that the Clerk should write to Dave Hewitt with a request that tree protection orders be placed upon the six trees surrounding the 1953 Coronation stone in the field off Skipton Road.

It was agreed that the section of Mill Lane approaching the bridge over the river was in a shocking state but that Lancashire Highways were unlikely to do anything about it.
